As of November 1<sup>st</sup>, 2011, the laws regarding disclosures and discovery in domestic relation actions have changed requiring more in depth documentation and verification relating to the parties assets and incomes to be provided for up front in all cases filed. This was done primarily in an effort to save money for the parties; however, it does require you to produce a significant amount of documentation from the outset of your case. Prior to us filing anything in your matter we will need for you to provide us with the following:

- Complete and accurate Financial Declaration (we will provide this form to you) along with attachments. Attachments include all of the following:
  - o For every item and amount listed in the Financial Declaration, excluding monthly expenses, you are required to attach copies of statements verifying the amounts listed on the Financial Declaration.
  - o For the two tax years before the petition was filed, you must produce complete federal and state income tax returns, including Form W-2 and supporting tax schedules and attachments. If you own or have an interest in a business you will also need to provide the federal and state income tax returns the business as well.
  - o Pay stubs and other evidence of all earned and un-earned income for the 12 months prior to the petition being filed.
  - o All loan applications and financial statements prepared or used by you within the 12 months prior to the petition being filed.
  - o Documents verifying the value of all real estate in which you have an interest, including, but not limited to, the most recent appraisal, tax valuation and refinance documents.
  - O All statements for the 3 months before the petition was filed for all financial accounts wherein your name is listed, including, but not limited to your checking, savings, money market funds, certificates of deposit, brokerage, investment, retirement, regardless of whether the account has been closed, including those held individually and jointly with another person or entity, or as a trustee or guardian, or in someone else's name on your behalf.
  - o If the documents listed above are not reasonably available or are in the possession of the other party, you are required to estimate the amounts entered on the Financial Declaration and state the basis for the estimation and provide an explanation as to why the documents are not available.

Failure to fully disclose all assets and income in the Financial Declaration and attachments may subject you to sanctions ordered by the court, including an award of the non-disclosed assets to the other party, attorney fees or other sanctions and the court deems appropriate.
